**ADDENDUM TO AGREEMENT  
BETWEEN UNIVERSIDAD COMPLUTENSE DE MADRID, SPAIN  
AND UNIVERSITÀ DEGLI STUDI FIRENZE, ITALY**

On the one hand, Dr. Dámaso López García, Vice-Rector for International Relations and Cooperation of the Universidad Complutense de Madrid (hereinafter UCM), appointed by Decreto Rectoral 32/2019, of June 14, and acting by delegation of the Rector according to Decreto Rectoral 1/2021, of January 11, establishing the Vice-Rectorships of the UCM, delegation of powers and various organizational issues, published in the Boletín Oficial de la Comunidad de Madrid on January 14, 2021.

And on the other hand, Dr. Alessandra Petrucci, Rector of the Università degli studi Firenze,

**Clause 1: Background**

On June 12, 2015, the last agreement between the Universidad Complutense de Madrid and the Università degli studi Firenze was signed for a period of validity until the 2020-21 academic year, in order to define shared specialties between the Master's Degree in Mathematics at the Università degli studi Firenze and the Master's Degree in Mathematical Engineering at the Universidad Complutense de Madrid with the purpose of granting study titles by both Institutions.

**Clause 2:**

Through this Addendum, both Institutions agree to extend the validity period of the same until the 2023/24 academic year, inclusive. The precise final date of validity will be the end of the academic year of the hosting institution.

Both parties agree that the students of the Università degli studi Firenze will carry out their Master's Thesis (Trabajo de Fin de Máster) at the Universidad Complutense de Madrid.

**Clause 3:**

The study plan of the Master's in Mathematical Engineering at UCM is undergoing a restructuring process. Once it is official, the current agreement will be revised to adapt it to the new study plan, prior notice from the UCM.

**Clause 4:**

The UCM and the Università degli studi Firenze declare that they maintain the other terms and conditions of the agreement signed on June 12, 2015 in force and without alterations.

**Clause 5:**

Regarding the processing of personal data, the UCM, in the development of its corresponding activities derived from this Agreement, will comply with the mandatory provisions established in Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 regarding the protection of natural persons with regard to the processing of personal data and the free circulation of these data.

And to express their conviction that this cooperation will contribute to enriching and strengthening the cultural and scientific development of the two institutions, the Universidad Complutense de Madrid and the Università degli studi Firenze sign this Addendum.
